Traffic Control: **PLEASE TRY NOT LET CARS ON THE COURSE**

For the streets inside the bike loop, please direct them to the exit at Darton and Croton

1. Stop traffic on Cyprus from entering Waynewood Blvd. and direct bikers toward Ft. Hunt Rd. (direction of arrows).
2. Direct bikers to turn right on Conover Pl.

3. Prevent cars from entering the course from residences and direct bikers to turn right on Croton.
4. Prevent cars from entering the course from Culver
5. Assist officer with exiting cars and spotting bikes
6. Prevent cars from entering the course from Doter
7. Prevent cars from coming down Waynewood Blvd. Dewolfe is open.
8. Prevent cars from entering the course from Dalebrook Dr. Direct them to exit.
